Discussion was held regarding the timeline, bandwidth issue and final costs for Bid No. 2018-13: Electronic Health Records (EHR) System for the Health Department. The Commissioners agreed to put this bid award on hold at this time and keep the bids received.

Commissioner Scheperle made a motion to approve and sign the Court Order for the Agreement for Services Rendered between the County of Cole and the Cole County Soil and Water Conservation District (in the amount of \$5,000.00 and expires January 31, 2019). Commissioner Hoelscher seconded the motion. The motion passed by a vote of: Commissioner Bushman (Yes), Commissioner Hoelscher (Yes), Commissioner Scheperle (Yes).

DISCUSSION:

Discussion was held regarding the Courthouse Complex Sidewalk and Drive Repair project. Commissioner Scheperle has been in contact with Sam Gaines Construction, who is currently working on a City project repairing streets and sidewalks. Gaines will hold the same pricing for the County as they bid for the City. No action taken today.

DISCUSSION:

Discussion was held regarding the investment options for the County through Central Bank. Treasurer Peters provided a handout for Commissioner's review showing current investments, Cole County Investment Account Interest Computation and County funds with more than \$1M (\$1,000,000.00) cash balance, all as of April 10, 2018. Additional discussion included keeping a balance of \$34M total in all fund accounts combined, investing additional monies at this time in 30/60/90 day note and the Treasurer coordinating with Auditor Berhorst and Finance Malzner in working together on the investment of the County's excess cash on short term notes instead of meeting with the Commissioners every 30 days.

MOTION:

Commissioner Scheperle made a motion to invest \$4M (\$4,000,000.00) in short term treasury for 30 days. Commissioner Hoelscher seconded the motion. The motion passed by a vote of: Commissioner Bushman (Yes), Commissioner Hoelscher (Yes), Commissioner Scheperle (Yes).

10. CLOSED SESSION

Commissioner Scheperle made a motion to go into Closed Session at 10:46 a.m. Pursuant to Section 610.021 of the Revised Statutes of Missouri, the Commission will go into Closed Session to discuss the following: Negotiated Contracts (Section 610.021 (12). Commissioner Bushman seconded the motion. The motion passed by a roll call vote of: Commissioner Bushman (Yes), Commissioner Hoelscher (Yes), Commissioner Scheperle (Yes).
