INTRODUCTION OF MEMBERS & GUESTS

Don Hillis called the meeting to order at 8:02 a.m.

MEETING MINUTES OF JUNE 12, 2019

Don Hillis made a motion to approve minutes as written. Bruce Dawson seconded the motion to approve minutes. Motion passed unanimously.

PROJECT STATUS REPORT

Eric Landwehr presented the project status report. A copy of the report was given to the members. Eric Landwehr stated that Tanner Bridge project may need to be extended into next year for a completion date. The Chip Seal Program is completed and the Asphalt Overlay Program is starting in September.

SMALL COMMUNITY COOPERATIVE PROJECT UPDATE

Eric Landwehr stated St. Thomas is completed. Centertown is in the process of working on the design. St. Martins received a grant through MoDOT and will add that to the funding from the County. They plan to complete their project in 2020. We have not heard an update from Russellville but from previous communications they are applying for extra funds through federal grants. No news from Wardsville.

GRAVEL ROAD UPGRADE POLICY REVISIONS

Eric Landwehr presented a list of discussion items for revising the gravel road policy. The goal is to have a revised policy completed by December 2020. The group discussed the various aspects of the discussion items.

LEAF ORDINANCE

Eric Landwehr presented a rough draft of a policy to address the disposing of leaves, tree limbs, grass clippings, mud and rock on ROW. The goal is reduce the amount of work county maintenance crews have to do to clean up messes left by others. Don Hillis suggested that the policy be specific and able to enforce.

NEW BUSINESS

BUSINESS 50 WEST DISCUSSION

Eric Landwehr and Paul Samson discussed to take the sidewalks to 8ft. with curb and gutter with greenway and walk space. The current design is 5' and St. Martins will be building an 8' walkway along their portion west of Route T. The members agreed unanimously to pursue an 8' sidewalk/greenway. There was also discussion on the limits of the 3 lane section and were to end it. It was unanimously agreed that we should end it where we currently have it designed to end west of Cheyenne Drive.

Motion to adjourn by Don Hillis, seconded by Kris Scheperle, the meeting was unanimously adjourned at 9:26 a.m.
