**Notice of Offices for Which Candidates are to be Nominated at

RSMo Section 115.345. Notice of offices for which candidates are to be nominated, when sent—election authority to publish notice with filing date.— 1. Not later than the third Monday in December immediately preceding the primary election, the secretary of state shall prepare and transmit to each election authority a notice, in writing, designating the offices for which candidates are to be nominated at the primary election.

2. Upon receipt of notice, the election authority shall publish the notice and the date by which candidates must file for such offices in a newspaper of general circulation in its jurisdiction.

NOTICE IS HEREBY GIVEN to persons wishing to file a declaration of candidacy to appear as a candidate for nomination at the primary election that filing will open on Tuesday, February 24, 2026 at 8:00 a.m. and will continue until Tuesday, March 31, 2026 at 5:00 p.m.

Notice of Voter Registration Accessibility

FURTHER NOTICE IS GIVEN that at least one-half of the sites provided for voter registration shall be accessible to handicapped persons (RSMo 115.140). In addition, a disabled or elderly citizen may register to vote by alternative means including registration by mail, and curbside registration.
